**Financial Services Enactments**

**1.** The following Acts shall be prescribed as “Financial Services Enactments” for the purposes of the Financial Services Commission Act—

- (a) Banking Act;
- (b) Company Management Act;
- (c) Co-operative Societies Act;
- (d) Fraudulent Dispositions Act;
- (e) Friendly Societies Act;
- (f) Insurance Act;
- (g) Money Laundering Reporting Authority Act;
- (h) Mutual Funds Act;
- (i) Protected Cell Companies Act;
- (j) Trust Companies and Offshore Banking Act;
- (k) Trusts Act.

**2.** These Regulations may be cited as the Financial Services Enactments Regulations, Revised Regulations of Anguilla F28-1.
