Financial Services Enactments

- (b) Co-operative Societies Act;
- (c) Fraudulent Dispositions Act;
- (d) Friendly Societies Act;
- (e) Insurance Act;

- (f) Money Services Businesses Act;
(R.A. 35/2011, s. 1)
- (g) Mutual Funds Act;
- (h) Protected Cell Companies Act[†];
- (i) Trust Companies and Offshore Banking Act;
- (j) Anguilla Utility Token Offering Act;
(R.A. 25/2018, s. 2)
- (k) Trusts Act;
- (l) Anguilla Utility Tokens Exchange Act.
