COMPANY MANAGEMENT FEES REGULATIONS

Note: These Regulations are enabled under section 25 of the Company Management Act, R.S.A. c. C75.

Interpretation

1. In these Regulations—

"Act" means the Company Management Act;

Fees

2. The fee for a service set out in Column 1 below is the amount set out opposite in Column 2—

	COLUMN 1	COLUMN 2
	Service	US\$
(1)	For filing application for licence under section 5 of the Act (Non-refundable)	500
(2)	For issue of a licence under section 6 of the Act—	
	(i) on or after 1st July in any year	1,000
	(ii) on or before 30th June in any year	2,000
(3)	For annual licence under section 8 of the Act	2,000.

Late payment of annual fees

- **3.** (1) In accordance with section 8 of the Act, the annual fee shall be paid on or before 15th January of each year.
- (2) If the annual fee is paid after 15th January in any year but before 1st March in the same year, a late payment penalty of 5% of the annual fee is payable in addition to the annual fee.
- (3) If the annual fee is paid after 15th January in any year but during the month of March in the same year, a late payment penalty of 25% of the annual fee is payable in addition to the annual fee.
- (4) If the annual fee is paid after 31st March in any year but on or before 30th June in the same year, a late payment penalty of 50% of the annual fee is payable in addition to the annual fee.

(5) If the annual fee and any applicable penalties are not paid on or before 30th June in the year in which the annual fee is due and payable, section 9(2) of the Act shall apply.
