## TRUST AND CORPORATE SERVICES PROVIDERS (FEES) REGULATIONS, 2024

Regulations made by the Governor under section 74 of the Trust and Corporate Services Providers Act, 2024.

#### Interpretation

1. In these Regulations—

"Act" means the Trust and Corporate Services Providers Act, 2024;

"\$" means the currency of the United States of America.
